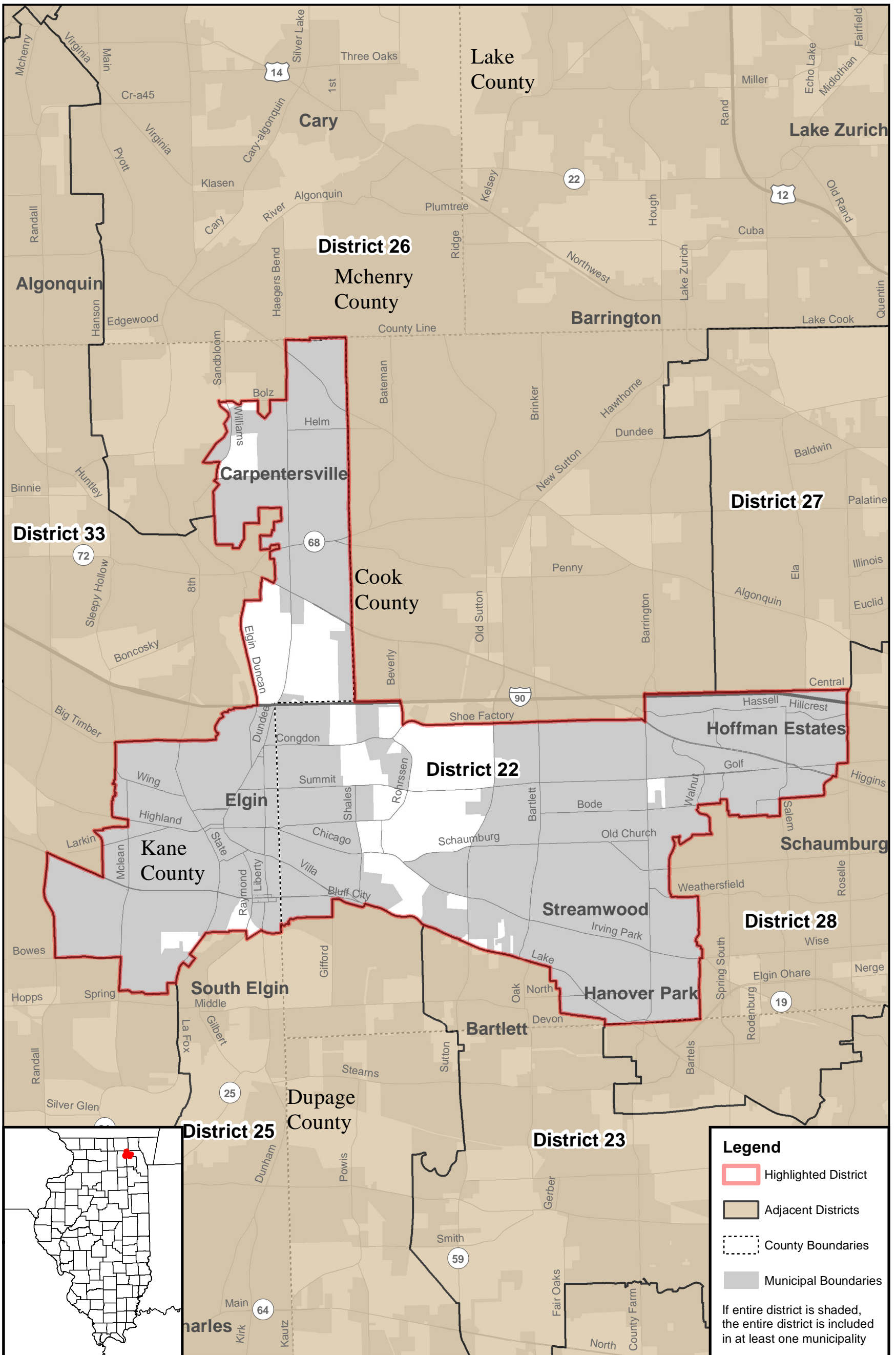


# Illinois Senate District 22

# Senate District 22

(Partially within Cook and Kane Counties)

Senate District 22 shall include that part of Illinois beginning at the intersection of Haegers Bend Rd and W. County Line Rd (the Cook / Kane County border in Barrington Hills),  
thence east along W. County Line Rd for approximately 2120 feet,  
thence north for approximately 230 feet,  
thence east for approximately 2680 feet to the intersection of Barrington Bourne and W. County Line Rd,  
thence east along W. County Line Rd to the Cook / Kane County border,  
thence south along the Cook / Kane County border to the north border of Section 5, T41N, R9E (3rd principal meridian), (in unincorporated Cook County) between Hoffman Estates and Elgin),  
thence east along the Hanover / Barrington Twp border to Beverly Rd,  
thence south along Beverly Rd to Shoe Factory Rd,  
thence east along Shoe Factory Rd and continuing east along the north border of Section 12, T41N, R 9E (3rd principal meridian) to W. Higgins Rd,  
thence southeast along W. Higgins Rd to Barrington Rd ,  
thence north along Barrington Rd to the Barrington Twp border,  
thence east along the Barrington / Schaumburg Twp border to N. Roselle Rd,  
thence south along N. Roselle Rd to W. Golf Rd,  
thence west along W. Golf Rd to the Schaumburg / Hoffman Estates municipal border,  
thence south along the Schaumburg / Hoffman Estates municipal border to W. Higgins Rd,  
thence west along W. Higgins Rd to Grand Canyon Pky,  
thence southwest and south along Grand Canyon Pky to Bode Rd,  
thence west along Bode Rd to N. Salem Dr,  
thence south along N. Salem Dr to Parker Dr,  
thence west along Parker Dr to Rugby Pl,  
thence approximately 150 feet north to the Hoffman Estates municipal border,  
thence west along the Schaumburg / Hoffman Estates municipal border to Bode Rd,  
thence west along Bode Rd to Downey St,  
thence north along Downey St to W. Hundley St,  
thence west along W. Hundley St to N. Hundley St,  
thence north along N. Hundley St to Hundley Way,  
thence west along Hundley Way for approximately 100 feet,  
thence north for approximately 970 feet,  
thence west for approximately 550 feet to Harmon Blvd,  
thence south along Harmon Blvd to Bode Rd,  
thence west along Bode Rd to N. Walnut Ln,  
thence south along N. Walnut Ln to Kingsley Dr,  
thence southeast along Kingsley Dr to Tebay Pl,  
thence south along Tebay Pl to a point approximately 70 feet south of Green River Dr,  
thence west for approximately 1700 feet to N. Walnut Ln,  
thence southwest along N. Walnut Ln to Skyvue Ln,  
thence north along Skyvue Ln and continuing north along Skyvue Ln (extended) to the shoreline of the lake east of Brent Ct,

thence west along Brent Ct (extended), and continuing west along Brent Ct to N. Knollwood Dr,  
thence south along N. Knollwood Dr to W. Weathersfield Way,  
thence east along W. Weathersfield Way to Kensington Ln,  
thence south along Kensington Ln for approximately 70 feet,  
thence east for approximately 1820 feet to the intersection of W. Weathersfield Way and S. Walnut Ln,  
thence south along the east border of Section 30, T41N, R10E (3rd principal meridian) to the intersection  
of Syracuse Ln and S. Walnut Ln,  
thence continuing south along S. Walnut Ln and S. Walnut Ln (extended), and continuing along Old  
Salem Rd to Taft Circle,  
thence southeast along Taft Circle to Madison St,  
thence south along Madison St to Olde Salem Circle,  
thence east along Olde Salem Circle to Truman St,  
thence south along Truman St to Roosevelt Rd,  
thence east along Roosevelt Rd to Olde Salem Circle,  
thence south along Olde Salem Circle to Irving Park Rd,  
thence west along Irving Park Rd to the northwest corner of Section 32, T41N, R10E (3rd principal  
meridian),  
thence south along the west border of Section 32, T41N, R10E (3rd principal meridian) to Westchester  
Dr,  
thence southwest to Walnut Av to a point approximately 90 feet west of the west border of Section 32,  
T41N, R10E (3rd principal meridian),  
thence continuing south to the Soo rail line / Dupage County border,  
thence west along the Cook / Dupage County border to the Bartlett municipal border,  
thence north along the Bartlett municipal border to the Soo rail line,  
thence west along the Soo rail line to S. Prospect Av,  
thence north along S. Prospect Av to E. Morse Av,  
thence west along E. Morse Av to N. Hale Av,  
thence north along N. Hale Av to E. Taylor Av,  
thence west along E. Taylor Av to Wayne Ct,  
thence north along Wayne Ct and continuing north along Wayne Ct (extended) to Lake St,  
thence northwest along Lake St to Bluff City Blvd,  
thence south and west along Bluff City Blvd to Gifford Rd,  
thence south along Gifford Rd to the south border of Section 19, T41N, R9E (3rd principal meridian),  
thence continuing south along Gifford Rd approximately 180 feet south of the border of Section 19,  
T41N, R9E (3rd principal meridian),  
thence west running parallel of the south border of Section 19, T41N, R9E (3rd principal meridian) to  
Poplar Creek,  
thence southwest along Poplar Creek to the Kane County border,  
thence south along the Kane / Cook County border to the Soo rail line,  
thence west along the Soo rail line to a point approximately 175 feet west of St. Charles St,  
thence southwest for approximately 1470 feet,  
thence north for approximately 750 feet to Raymond St,  
thence west for approximately 1500 feet to the Fox River,  
thence south along the Fox River for approximately 110 feet,  
thence west for approximately 2000 feet to N. La Fox St,  
thence southwest along N. La Fox St to Beck Av,  
thence southeast along Beck Av to its terminus,  
thence southwest to the terminus of Mavis Av,

thence northwest along Mavis Av to N. La Fox St,  
thence south along N. La Fox St to Division St,  
thence west along Division St to N. Collins St (extended),  
thence south along N. Collins St (extended), and continuing south along N. Collins St to Kane St,  
thence west along Kane St to S. McLean Blvd,  
thence north along S. McLean Blvd to Bowes Rd,  
thence west along Bowes Rd to Randall Rd,  
thence north along Randall Rd to US 20/Ulysses S. Grant Memorial Hwy,  
thence southeast along US 20/Ulysses S. Grant Memorial Hwy, to S. Lyle Av (extended),  
thence north along S. Lyle Av (extended), and continuing north along S. Lyle Av to Lin Lor Ln,  
thence east along Lin Lor Ln to Thomas More Dr,  
thence north along Thomas More Dr for approximately 140 feet,  
thence east for approximately 640 feet to Lin Lor Dr,  
thence continuing east along Lin Lor Dr / Easy St to N. McLean Blvd,  
thence north along N. McLean Blvd to W. Highland Av,  
thence west along W. Highland Av to Hoxie Av,  
thence north along Hoxie Av , and continuing north along Hoxie Av (extended) to Tyler Creek,  
thence north along Tyler Creek to a point approximately 1230 feet south of the intersection of Royal Blvd and N. McLean Blvd,  
thence north for approximately 1230 feet to the intersection of Royal Blvd and N. McLean Blvd,  
thence north along N. McLean Blvd to Big Timber Rd,  
thence east along Big Timber Rd to N. State St,  
thence continuing east for approximately 3125 feet to the Fox River,  
thence north for approximately 340 feet to Catherine Lane Rd,  
thence northeast along Catherine Lane Rd to Bayview Rd,  
thence west along Bayview Rd to Lakeview Rd,  
thence northeast along Lakeview Rd to Bridgeview Rd,  
thence north along Bridgeview Rd to Melbrooke Rd,  
thence northeast and east along Melbrooke Rd to Willow Lake Rd,  
thence north along Willow Lake Rd to Tollview Rd,  
thence east along Tollview Rd to Exit Rd,  
thence north along Exit Rd to W. River Rd,  
thence east along W. River Rd and continuing east along W. River Rd (extended) to the Fox River,  
thence north along the Fox River to I-90,  
thence east along I-90 to Duncan Av,  
thence north along Duncan Av to Elgin Av,  
thence continuing north along Elgin Av to the E. Dundee municipal border,  
thence east and north along the E. Dundee municipal border and continuing north to E. Main St,  
thence southeast along E. Main St to Howard Av ,  
thence north along Howard Av to Park St,  
thence west along Park St to Aldis Dr,  
thence north along Aldis Dr to Barrington Av,  
thence east along Barrington Av to the Carpentersville municipal border,  
thence north, west, north, east, north, west, south and west along the Carpentersville / E. Dundee municipal border to Wilmette Av,  
thence south along Wilmette Av to N. Van Buren St,  
thence southwest along N. Van Buren St. to Roslyn Rd,

thence continuing on Roslyn Rd (extended) west, south, west, north, west, and north along the Carpentersville / E. Dundee municipal border to Carpenter Blvd (extended),  
thence north along Carpenter Blvd (extended) and continuing north along Carpenter Blvd to Maple Av,  
thence west along Maple Av to Brook St,  
thence north along Brook St and continuing north along Brook St (extended) for approximately 1225 feet,  
thence northeast for approximately 760 feet,  
thence northwest for approximately 530 feet to Williams St,  
thence northeast along Williams St to Williams Rd,  
thence north along Williams Rd to the south border of Section 10, T42N, R8E, (3rd principal meridian),  
thence west along the south border of Section 10, T42N, R8E, (3rd principal meridian) to the Fox River,  
thence northeast along the Fox River to Angelina Pl (extended),  
thence east along Angelina Pl (extended) and continuing east along Angelina Pl to Bolz Rd,  
thence continuing east along Bolz Rd to Amarillo Dr,  
thence south and southeast along Amarillo Dr to Ensenada Dr,  
thence northeast and north along Ensenada Dr to Bolz Rd,  
thence east along Bolz Rd to Elgin Rd,  
thence north along Elgin Rd and continuing north along Haegens Bend Rd to the point of beginning.
